## TUITION WAIVER INSTRUCTIONS FOR THE UNEMPLOYED

### Summer 2009

Unemployed students may have their tuition and registration fee waived under the following conditions.

The student must present the following completed and signed forms:

- a) R. I. Public Higher Education "Unemployed Means Test"
- b) D. E. T. "Certification of UI Eligibility" (must be dated  
after March 18, 2009 and before May 18, 2009 for Summer Session I  
after April 22, 2009 and before June 22, 2009 for Summer Session II)
- c) Signed copy of 2008 Federal Form 1040, 1040A or 1040EZ
- d) Copy of all 2008 Forms W2 of the Unemployed

When Submitting the forms for review and approval, payment of the required fees must also be presented.

Tuition waiver requests will not be honored if any forms are not complete, are missing, or, if the appropriate payment is not presented.

Courses must be taken for credit. Audit forms cannot be accepted from students using DES waivers.

Students adding a SS II course, after initially registering for SS I, will be required to provide a second DET -467 form with the appropriate dates recorded if their original waiver was dated before 4/23/09 (waivers dated between 4/23/09 - 5/17/09 will cover both Sessions I & II).

#### IMPORTANT NOTICE:

Matriculating students wishing to use an Unemployment tuition waiver must complete a Free Financial Aid form for the 2008 - 2009 school year. Please apply online at: [www.fafsa.ed.gov](http://www.fafsa.ed.gov).

Proof of your financial aid application will be confirmed by a staff member. Your tuition waiver will be returned if you do not complete the FAFSA application. In step 6 of the FAFSA form, all students should enter 003414 University of Rhode Island, Kingston, RI.

If the DES waiver is approved, its value will be replaced by any grant or scholarship aid received per the General Laws of the State of Rhode Island.
