- a. Update on development of COP student newsletter – Drew and Kappa Psi
  - i. Considering putting together a monthly college calendar with exams and events
  - ii. Will highlight fundraising
- b. Elective Discussion – Purpose was to help in future selection and scheduling of electives:
  - i. Requirements: exams, papers, projects - mini-syllabus
  - ii. List of electives needs to come out earlier
    - 1. Maybe also gauge possible interest ahead of time
  - iii. Opportunities may be there one year, but not the next (ie: P3s were only able to have palliative care and pediatrics the previous year due to scheduling – they would have preferred to know that last year when they had the opportunity)
    - 1. Maybe offer double semester electives?
  - iv. Scheduling
    - 1. Students are included in the scheduling process
    - 2. Conflicts with lab, IAL, and electives for P3
    - 3. Each class can have one day allocated for early experience/electives
  - v. Those with AP credits get the first pick of classes and you get stuck with whatever is left, everyone should be able to pick at the same time.
    - 1. Students with disabilities and athletes usually get to still go first
  - vi. Appeals process for those who are really interested in a certain elective that will help you in the future (ie: student interested in specializing in diabetes cannot get into GI endo).
- c. Mission and Vision Statement – Dr. Barbour asked SLC to review the mission and vision statements developed for the College.
  - i. Vision
    - 1. Don't like "illuminates a path" and "merging entrepreneurial spirit" – fluffy, not really saying anything that would really represent pharmacy. Strongly would suggest dropping entrepreneurial spirit.
    - 2. Too long. It loses reader attention. It should end at "healthcare"

3. Drop either innovate or illuminate.
  4. Rewritten:
    - a. We will lead through pharmacy education, with research and practice that illuminates a path toward effective global health care.
  - ii. Mission
    1. OK
  - iii. Value
    1. Just say “Diversity and respect for all individuals” – drop multiculturalism, not necessary with current statement and would include multicultural
  - iv. Slogan
    1. Generic, not well liked
    2. Like “education”, but not “greater good”
      - a. “Bringing education into practice”
      - b. “It’s not just a job, it’s a commitment”
  - v. Overall
    1. Too much repetition
      - a. “Innovation” is used in all 3 parts – not sure if that’s an issue
